However, tuition fees will be refunded only in the following circumstances: (a) University / institute cancels the course; (b) The student must submit—a written evidence which the application of student visa has been rejected by the Australian government (This is excluded—where a student visa renewal is rejected or the cancellation of a student visa subject to the breach of visa conditions); (c) University or institute receives a written notice of cancellation of enrolment from the student at least 28 days before the first day of the course. In addition, University/Institute will have right to retain 20% or more of the course fee paid if enrolment is cancelled by the student for reasons other than a rejection of a student visa. Course fees will not be refunded to student: (a) once the course has commenced. Or (b) The student cancels the enrolment for the reasons other than the rejection of a student visa and less than 28 days prior to the commencement date of the course. In conclusion, All tuition fees will be refunded subject to related educational institution refund term and policy. In addition, accommodation fees/home stay will be refunded provided two weeks notice is given before the commencement date.
